- 2. Forms may be faxed to Clark Synthesis. An initial order may be placed based on acceptance of faxed forms. Dealer agrees to submit original forms to Clark Synthesis. If the original dealer application forms are not received at Clark Synthesis, additional orders will not be processed.
- 3. Payment terms for an initial order are Prepaid / Credit Card. All accounts are Credit Card / COD / Prepaid until a credit application has been completed, reviewed, and approved.
- 4. Clark Synthesis, Inc., and its representatives have made no representations, assurances, or guarantees as to the profitability or success of the proposed dealership, and that the ultimate profitability or success of the proposed dealership may depend on future market conditions and economic factors that are beyond the Dealer's and Clark Synthesis, Inc.'s control. As a result, the Dealer's investment in the proposed dealership is made solely at the applicant's risk.
- 5. All shipments are F.O.B. Littleton, Colorado, USA, unless otherwise specified. Product subject to availability. Seller's acceptance of order is conditional. Seller shall not be liable to Dealer for failure to fulfill quantity, delivery or other terms if delays are incurred due to production, transit, or causes beyond seller's control.
- 6. Dealer must notify Clark Synthesis of defective merchandise within 30 days of date of receipt. Returns will only be accepted for defective product. Call to request a Return Authorization Number. Unauthorized returns will not be accepted and will be returned at the Dealer's expense. Clark Synthesis is not responsible for damages caused by misapplication of any products.
- 7. Dealer understands and agrees that the products are not medical devices and are never offered or intended for medical treatment of any diseases or disorders. Dealer understands and agrees that they will not make any medical claims relating to any Clark Synthesis, Inc. product.
- 8. This agreement shall be governed by the state laws of Colorado. Clark Synthesis, Inc., or the Dealer may terminate this agreement at any time by written notice.
